## 2021 Part B Surveys

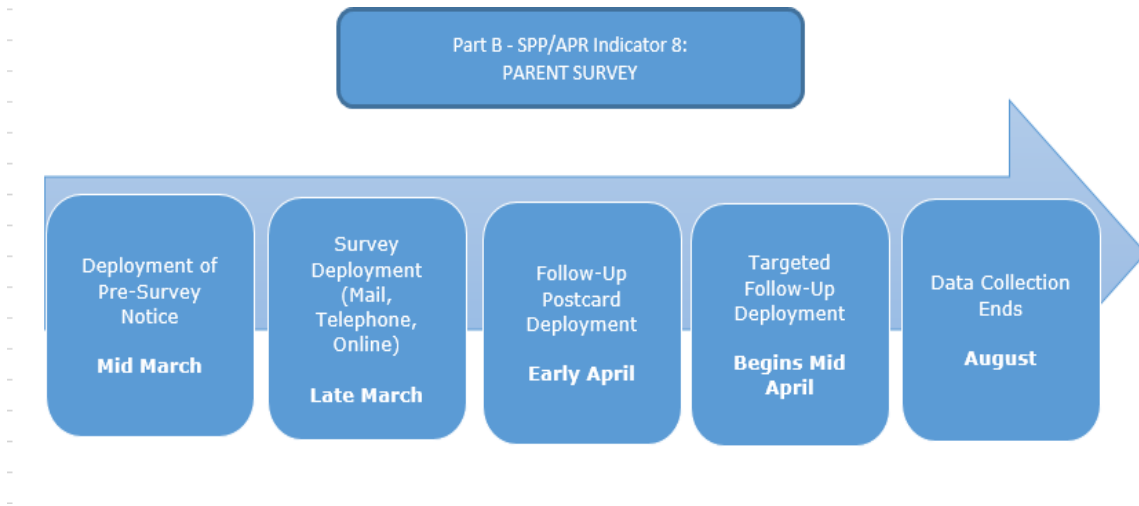

### **School Involvement Considered Inappropriate Because of Privacy and Other Concerns:**

In order to align the Parent Survey with best research practices, there are certain aspects of the survey process that school officials cannot do as part of the survey. Below are activities in which school officials should **not** participate.

- In order to maintain the privacy of students and parents, school officials cannot have access to any of our identifying parent and student data, including specific information about which parents have and have not completed the survey.
- To maintain research standards, school officials cannot say to parents and students that participation in the survey is mandatory.

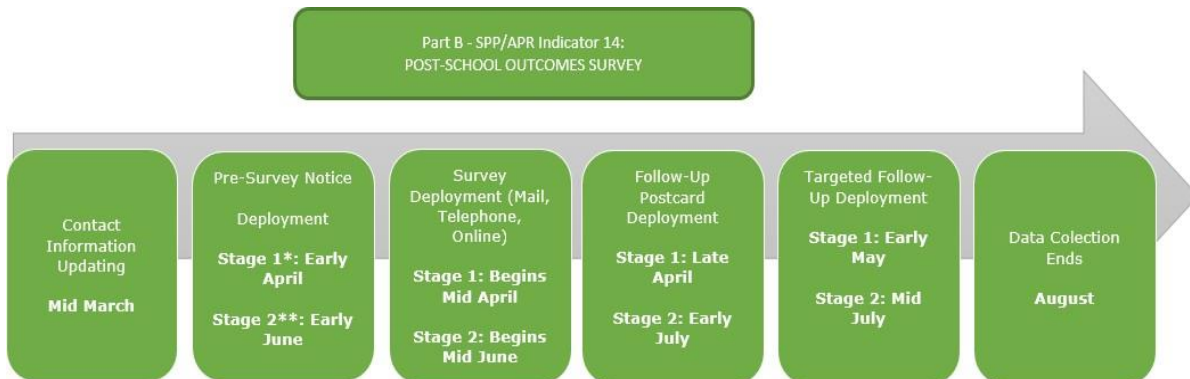
